To qualify, the applicant must be a member in good standing of The National Arts Club for at least one year, and be a practicing professional visual artist. Admission to the EAM is highly selective; each application, including the required attachments, receives thorough review prior to the awarding of EAM status.

Exhibiting Artist Members are committed to advancing the NAC's educational and cultural mission as a not-for-profit organization, through the presentation of quality artworks in exhibitions and supporting arts and cultural programming.

EAM Members are invited to show their artwork in the annual juried EAM Exhibition in the NAC's prestigious Grand Gallery. Exhibiting Artist Members also benefit from special rental rates to exhibit in the Club's Gregg & Marquis Galleries.

Applications are only accepted by email. Please download, print and complete all sections of this application form, then scan and return by email to ryahner@thenationalartsclub.org. The subject line must include your name and indicate "EAM Application."

REQUIRED ATTACHMENTS TO THE APPLICATION

Applicants are required to submit five (5) images representative of their current studio practice. Images must be submitted in digital format only. Images should be submitted by email to ryahner@thenationalartsclub.org. Attach the five (5) images to the email with your EAM application form. The images will be viewed on the computer, therefore the images only need to be 72dpi. Format images to be about 8 x 10 inches.

Please be sure that each of your five (5) image submissions are properly labeled (see below). Images of artwork should exclude frames, mats, easels, fingers or other supports. Do not send original artwork or hard copy photos, brochures, etc.; these cannot be returned and will be discarded.

Artwork submissions must be limited to works created within the last five (5) years; artwork should represent original content, exemplify current practice, and reflect your unique style and technique. Classwork, workshop projects or published artworks are not acceptable.

All image submissions must include an accurate listing of each individual work as outlined below:

1. Title of work
2. Media (e.g. oil on canvas, bronze, etc.)
3. Dimensions (height first, excluding mat or frame)
4. Year the work was completed
